Social Probation Ë can be used to limit and/or restrict social functions.

Intramural Probation Ë can be used to limit and/or restrict intramural participation.

Event Probation Ë can be used to limit and/or restrict other campus and chapter events.

Recruitment Probation Ë can be used to limit and/or restrict participation in formal/informal recruitment.

Restitution Ë Monetary Reimbursement for damages of property.

Monetary Fines

Educational Programming Ë A percentage of the chapter membership must attend/sponsor/co-sponsor a program relevant to the violation. The percentage will be decided by the Investigating Officer and approved by the Hearing Officer.

Community Restitution Ë A percentage of the chapter membership must complete a certain amount of community restitution hours. The percentage and amount of hours will be decided by the Investigating Officer and approved by the Hearing Officer.
